COURSE EXCEPTIONS – Senior Citizens may not enrolled in internships, distance degree program courses, correspondence courses, courses numbered 499, 600, 700, 702, and 800 and self supporting courses (including all summer session courses) under this fee waiver.

CHARGES – Senior Citizens enrolled with this fee waiver pay a \$5.00 non-refundable administrative fee plus any special course fees, laboratory fees, or later registration fees. Fees must be paid according to published payment deadlines for the term.
